

TERMS AND CONDITIONS

PRICES AND PAYMENT

TVF Productions reserve the right to change prices at any time. However once a booking is confirmed in writing, prices will be honoured except under exceptional circumstances. A booking of £85 is required at the time of booking. The difference between the deposit and the agreed cost of the Video/DVD and or Photographs is payable before the date of the wedding. Payment for additional Video/DVD's and or Photographs must accompany the order. Payments are accepted in cash or cheque. Should a cheque be returned by the bank, for any reason, an additional charge of £15 will be applied each time. Receipts will be issued for all monies paid. Cheques should be made payable to TVF. Video/DVD and or Photographs will not be given until cheques are cleared. All videos remain the property of TVF Productions until full payment is received and cleared through our bank. Any Agreed travel costs will be added to the invoice.

CANCELLATIONS

In the event of cancellation the following will apply:-
More than 6 months prior to wedding deposit less £25 will be refunded
Between 6 months and 2 months prior to wedding no deposit will be refunded.
Within 2 calendar months of the wedding the full amount is payable.

TVF also ask for your co-operation on the day as we want to do the best for you. Although TVF take precautions to ensure the day goes smoothly, we do not control the events. Whatsoever the cause, the amount of compensation will not exceed the amount paid for the video.

TVF reserves the right to terminate coverage at any time, without penalty, if guests become abusive, threaten violence or damage any equipment. Any injuries, repairs to clothing or to damaged equipment resulting from such acts will be the responsibility of the person(s) booking the photography.
